Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001 on Tuesday, December 4, 2012, on the following application:

Application of West End Residential Properties LLC, on behalf of the District of Columbia, pursuant to 11 DCMR § 3104.1 and 3103.2, for a variance from the public space requirements under section 633, a variance from the court requirements under section 638, a variance from the off-street parking requirements under subsection 2101.1, and a variance from the loading requirements under subsection 2201.1, and special exception approval from the roof structure provisions under subsections 411.5, and 630.4, to allow a mixed-use project that consists of a new fire station at the ground level, recreational or commercial use, and an apartment house in the CR District at premises 2225 M Street, N.W. (Square 50, Lot 822).

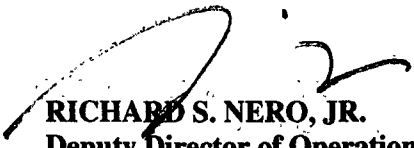
