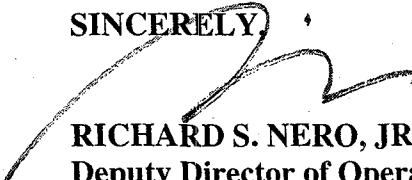
Application of Quiton Cooper, pursuant to 11 DCMR § 3104.1, for a special exception to allow additions (cellar, third floor and roof penthouse/deck) to an existing one-family semi-detached dwelling under section 223, not meeting the lot occupancy (section 403), rear yard (section 404), side yard (section 405) and court (section 406) requirements in the R-4 District at premises 513 U Street, N.W. (Square 3079, Lot 28).

All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 1B.
