At a properly noticed Advisory Neighborhood Commission 4C meeting with a quorum present held on October 10th, 2012, the 4C Commission voted unanimously to offer support for BZA Special Exception Application No 18464 requesting permission to increase the number of children permitted at the 2 New Heights Child Development Center located at 4124 3rd Street, NW from 16 to a total of 24 children

The owner and operator of 2 New Heights Child Development Center presented their request to the community and the full 4C Commission Citing letters of support from immediate neighbors and an unmet demand for high quality, educationally-focused child care in the neighborhood, the Commission voted to support the request
