Application of Universalist National Memorial Church, pursuant to 11 DCMR § 3103.2, for a variance from the use provisions for theater performances on the basement level of a church under subsection 350.4, in the DC/R-5-B District at premises 1810 16th Street, N.W. (Square 177, Lot 802).
