Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Tuesday, March 22, 2016 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Universalist National Memorial Church, pursuant to 11 DCMR § 3103.2, for a variance from the use requirements under § 350.4, to allow the continued use of theater performances on the basement level of a church in the DC/R-5-B District at premises 1810 16th Street N.W. (Square 177, Lot 802).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

In order to review exhibits in the case, follow these steps:
