Application of The Preparatory School of D.C., pursuant to 11 DCMR § 3104.1, for special exception to allow an increase in the number of child development center students from 15 to 29 students under section 205, in the R-5-B District at premises 3220 17th Street, N.W. (Square 2607, Lot 2023).
