Notice is hereby given that the Board of Zoning Adjustment (BZA) has tentatively placed the following application on its Expedited Review Calendar for a decision without a public hearing at 441 4th Street, N.W., Suite 200 South, Washington, D.C., 20001 on November 27, 2012, at 9:30 a.m. This is also the location of the Office of Zoning.

Application of Christian Creech, pursuant to 11 DCMR § 3104.1, for a special exception to rebuild, renovate and make additions to an existing vacant building for one-family occupancy under section 223, not meeting the lot area requirements under section 401, lot occupancy requirements under section 403, open court requirements under section 406 and nonconforming structure requirements under subsection 2001.3, in the R-4 District at premises 1400 Montello Avenue, N.E. (Square 4059, Lot 29).

The BZA Chairperson may deny a request to remove an application if the proffered testimony is irrelevant. If this application is removed, the only public notice of the hearing date will be posted in the Office of Zoning up until the date of the hearing.
