Subject: Zoning Commissioner Application Case No. 18482

Mohammad Sikder (applicant) located at 5008 13th Street, NW (Squares 2806, Lot53) has applied to the Board of Zoning Adjustment (BZA) of the District of Columbia for a zoning Variance from a minimum lot area, minimum lot width, and side Yard requirements of R-1-B Zone Pursuant to 11 DCMR § 3103.2 under section 401 & 405.

The 4C ANC Commission respectfully thanks the Zoning Commission for granting an postponement of the BZA Application Case No. 18482 to allow both the 4C ANC Commission and the applicant Mohammad Sikder an opportunity to have his case properly vetted with the residents and 4C ANC Commissioners at the 4C ANC Commission Community meeting on January 16, 2013, and to allow for the 4C ANC Commissioners to take a vote and consideration for the ANC great weight.

At a properly noticed meeting held on January 16, 2013, with a quorum present at the Advisory Neighborhood Commission 4C meeting, a motion by Commissioner Janet Myers was presented; the motion was seconded, and passed unanimously to support the application of Mohammad Sikder (applicant) with conditions. Mr. Sikder presented his proposal to the community, received, and responded to 4C Commissioner's and community questions, issues, and concerns. Residents impacted by the proposed plans requested the following conditions, and respectfully requested the 4C Commission to only support the applicant if he agrees to honor the resident's conditions. Mr. Sikder agreed publicly at the 4C ANC community meeting to honor the following conditions:

- 1) The vacant lot is restored back to its original dwelling – a single family house that conforms to the current structure of homes within the neighborhood.
- 2) The proposed project's intent is specifically to build a single family house on the vacant lot for residential/living purposes for Mr. Sikder's family- No usage for rental of the property as a boarding facility for purposes to serve multiples of residents living quarters; No transitional group home facility; No transitional housing; and No transferal to Condo/Apartment.

Based on the foregoing, ANC 4C Commission respectfully request that the Board of Zoning Adjustment give great weight to the Commission's position to support the zoning variance from a minimum lot area, minimum lot width, and side Yard requirements, along with the requested conditions of the residents, and agreed upon by Mr. Sikder at the ANC 4C Community Meeting held on January 16, 2013.
