**Application of Jonathan Grossman**, pursuant to 11 DCMR § 3103.2, for a variance from the floor area ratio requirements under section 402, a variance from the lot occupancy requirements under section 403, a variance from the rear yard requirements under section 404, and a variance from the nonconforming structure requirements under subsection 2001.3, to allow an addition to an existing row dwelling in the DC/R-5-B District at premises 1751 18<sup>th</sup> Street, N.W. (Square 153, Lot 95).
