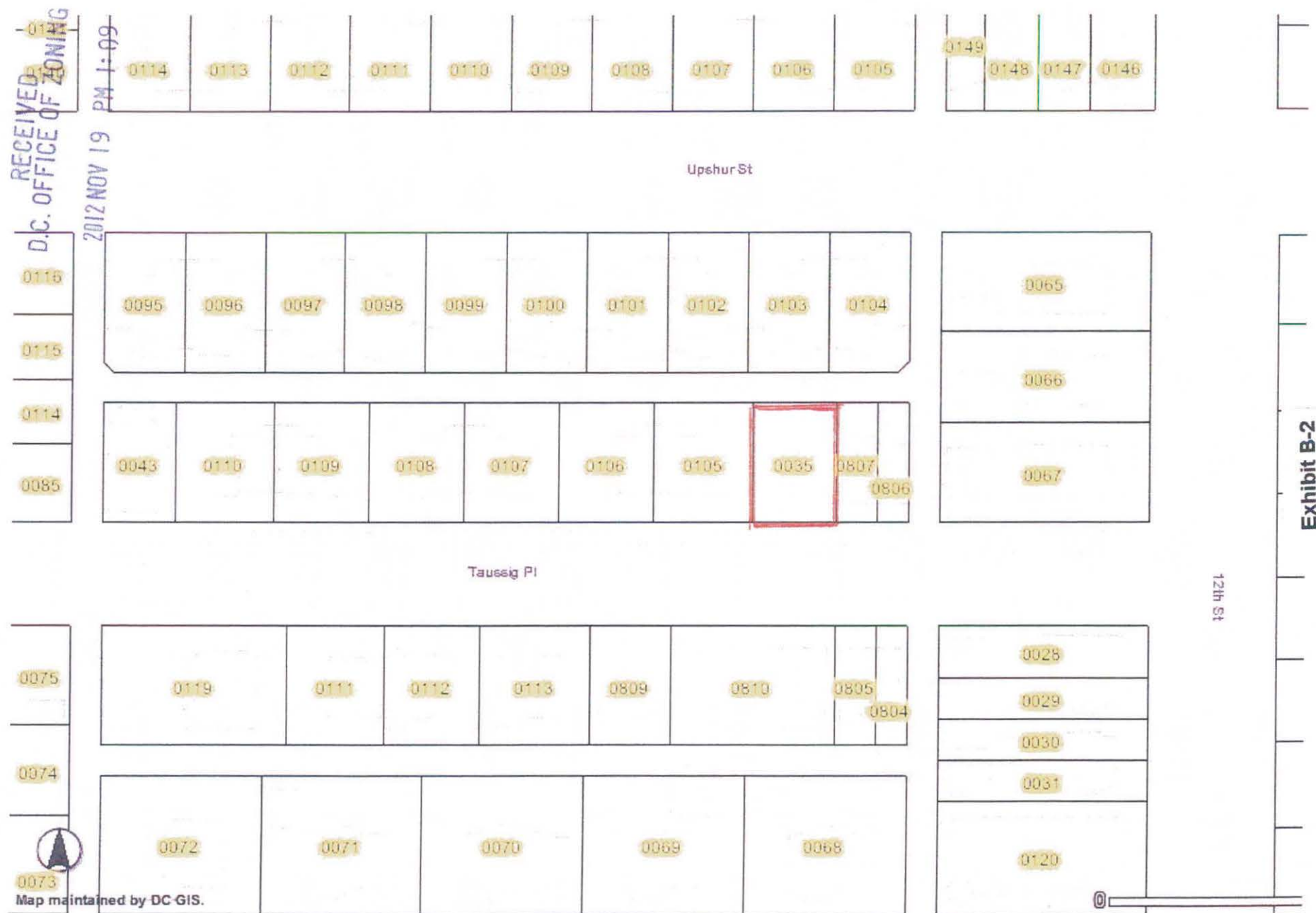

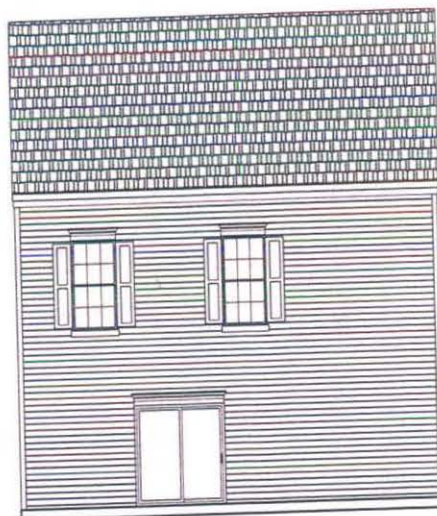

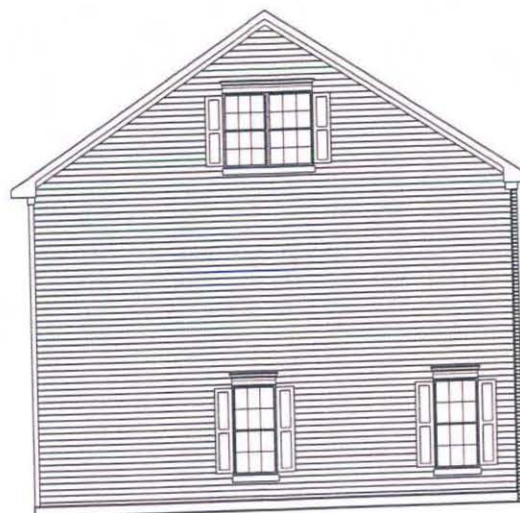

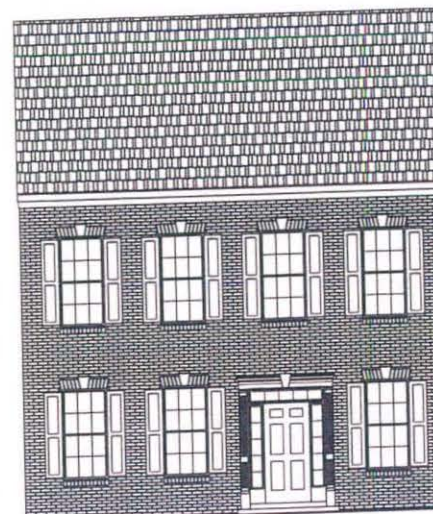
REAR ELEVATION
