Application of Keystar Spring Place LLC, pursuant to 11 DCMR § 3103.2, for a variance from the off-street parking requirements under subsection 2101.1, and a variance from the loading berth and service and delivery space requirements under subsection 2201.1, to construct a new 864 unit apartment building in the C-2-A District at premises 1795 Bull Place, N.W. and 7051-7053 Spring Place, N.W. (Square 3185, Lots 52 and 822).

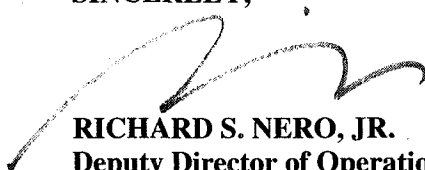
