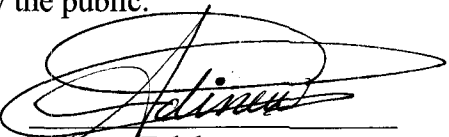

Adinew Zeleke, being first duly sworn, does hereby depose and say that:

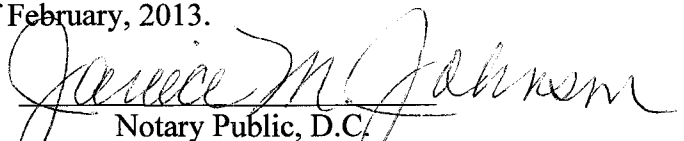

I caused to be taken seven (7) photographs of the Notices in place, attached hereto as Exhibit A, which photographs fairly depict the Notices as seen by the public.

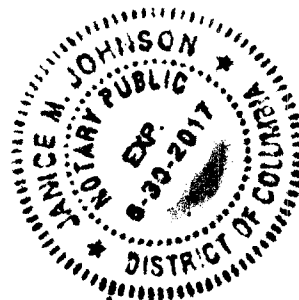
