Application of Ronald J. and Karen K. Thomas, pursuant to 11 DCMR § 3104.1, for a special exception for a rear screen porch addition to a one-family semi-detached dwelling under section 223, not meeting the lot occupancy (section 403), side yard (section 405), and nonconforming structure (subsection 2001.3) requirements in the R-3 District at premises 3014 P Street, N.W. (Square 1257, Lot 841).

All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded.
