Application of Joshua Glickman, pursuant to 11 DCMR § 3104.1, for a special exception for parking on an alley lot under section 333, in the R-4 District at premises rear 1015-1017 Irving Street, N.W. (Square 2846, Lot 114).

This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 1A. 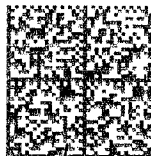

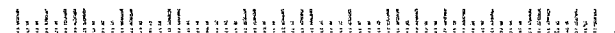
