Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001 on Tuesday, March 12, 2013, on the following application:

Application of 200 5th Street SE LLC, pursuant to 11 DCMR § 3103.2, for a variance from the lot area requirements under subsection 401.11, to convert a structure from four residential units and a dental office into a six residential unit apartment house in the CAP/R-4 District at premises 200 5th Street, S.E. (Square 843, Lot 18).

At the public hearing, all interested persons will be given an opportunity to express their views. However, in lieu of appearing at the hearing you may also submit written views about this case. All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded. 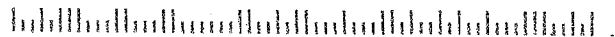

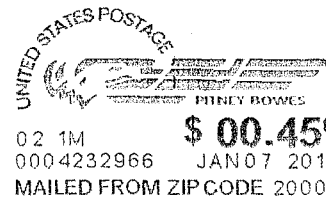
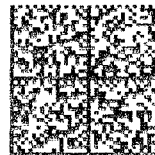
