**Application of YMCA Capitol View**, pursuant to 11 DCMR § 3104.1, for a special exception for a Child Development Center – Before and After School Program (150 children and 8 staff) under section 205, in the R-5-A District at premises 4275 4<sup>th</sup> Street, S.E. (Square 6242, Lot 834).
