Application of Gregory Igbozuruike, pursuant to 11 DCMR § 3103.2, for a variance from the lot width requirements under subsection 401.3, to allow the construction of three new flats in the R-4 District at premises 429 Newton Street, N.W. (Square 3035, Lots 82 and 83).
