Application of 819 6th St LLC, pursuant to 11 DCMR § 3103.2, for a variance from the lot occupancy requirements under section 403, and a variance from the rear yard requirements under section 404, to allow the construction of an apartment building in the DD/R-5-E District at premises 819 6th Street, N.W. (Square 485, Lot 15).
