Application of Brian and Christy Davis, pursuant to 11 DCMR § 3104.1, for a special exception for a two-story rear addition to a one-family row dwelling under section 223, not meeting the lot occupancy requirements (section 403), and nonconforming structure requirements (subsection 2001.3) in the R-4 District at premises 1329 F Street, N.E. (Square 1029, Lot 169).

This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 6A.
