Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001 on Tuesday, April 9, 2013, on the following application:

Application of Perseus 1827 Adams Mill Investments LLC, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a variance from the number of required parking spaces under subsection 2101.1, a variance from the of parking space location requirements under subsection 2116.4(a), and a special exception from the roof structure requirements under subsection 411.11, to allow the construction of a mixed-use retail, service and residential building in the C-2-A District at premises 1827 Adams Mill Road, N.W. (Square 2580, Lot 853).

All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded.
