Application of Dean Street Mews LLC, pursuant to 11 DCMR § 3103.2, for a variance from the lot area and lot width requirements under subsection 401.3, and a variance from the side yard requirements under section 405, to allow the construction of two semi-detached dwellings in the R-2 District at premises 4601 and 4603 Grant Street, N.E. (Square 5145, Lots 10 and 11).

All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 7C. 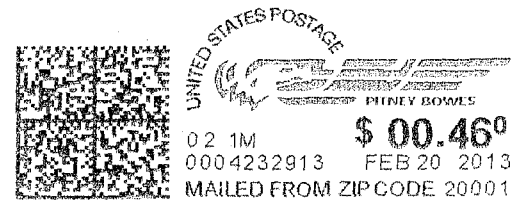
