Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001 on Tuesday, May 7, 2013, on the following application:

Application of Valor 1350 Maryland LLC, pursuant to 11 DCMR §§ 3104.1, 3103.2, and 1325.1, for a variance from parking setback requirements under subsection 2116.12, and a special exception to allow a new residential building on a lot with more than 6,000 square feet of land area under subsection 1320.4, in the HS-C-3-A District at premises 1350 Maryland Avenue, N.E. (Square 1027, Lots 141, 142, 143 and 849).

At the public hearing, all interested persons will be given an opportunity to express their views. However, in lieu of appearing at the hearing you may also submit written views about this case. All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded. You are encouraged to submit your written testimony ten days in advance of the hearing to ensure your document is given due consideration. Except for the affected ANC, any person who desires to participate as a **party in this case must clearly demonstrate that the person's interests would likely be more significantly, distinctly, or uniquely affected by the proposed zoning action than other persons in the general public.** If you are unsure of what it means to participate as a party and would like more information on this, please contact the Office of Zoning at dcoz@dc.gov or at (202) 727-6311.

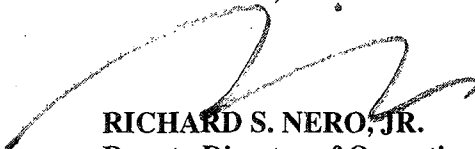
