Application of Einstein and Noah Corp., pursuant to 11 DCMR §§ 3104.1 and 1533.1, for a special exception for a fast food establishment under section 773, in the NO/C-2-A District on the first floor of 2233 Wisconsin Avenue, N.W. (Square 1299, Lot 1006).

Persons seeking party status shall file with the Board, not less than 14 days prior to the date set for the hearing, a Form 140 – Party Status Request form, a copy of which may be downloaded from the Office of Zoning's website at: <http://dcoz.dc.gov/services/app.shtm>. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 3B. 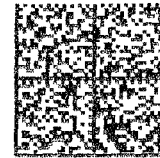

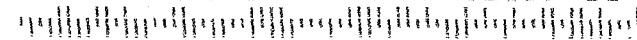
