Application of Shiau Feng Chen, pursuant to 11 DCMR § 3104.2, for a special exception to establish a pet grooming establishment under section 736, in the C-2-A District at premises 4824 MacArthur Boulevard, N.W. (Square 1388, Lot 25).

Persons seeking party status shall file with the Board, not less than 14 days prior to the date set for the hearing, a Form 140 – Party Status Request form, a copy of which may be downloaded from the Office of Zoning's website at: <http://dcoz.dc.gov/services/app.shtm>. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 3D.
