**Application of Kathleen M. Sullivan**, pursuant to 11 DCMR § 3103.2, for a variance from the use provisions to establish a rental apartment unit in the basement of a one-family row dwelling under subsection 320.3, in the R-3 District at premises 4463 Greenwich Parkway, N.W. (Square 1350, Lot 80).

All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded. Persons seeking party status shall file with the Board, not less than 14 days prior to the date set for the hearing, a Form 140 – Party Status Request form, a copy of which may be downloaded from the Office of Zoning's website at: <http://dcoz.dc.gov/services/app.shtm>. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 3D. 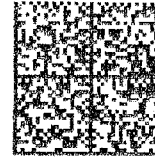

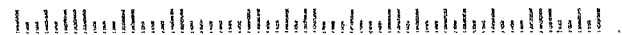

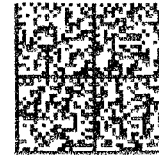
