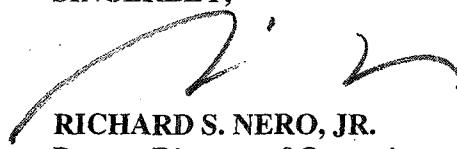
Application of Stjepan Sostaric on behalf of Greater Washington Animal Services Inc., d/b/a City Dogs, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a special exception to allow animal boarding under section 735, and a variance for accessory pet grooming for dogs under subsection 735.2, in the C-2-A at premises 1310 Pennsylvania Avenue, S.E. (Square 1043, Lot 865).

All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded. Persons seeking party status shall file with the Board, not less than 14 days prior to the date set for the hearing, a Form 140 – Party Status Request form, a copy of which may be downloaded from the Office of Zoning's website at: <http://dcoz.dc.gov/services/app.shtm>. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 6B. 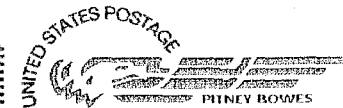
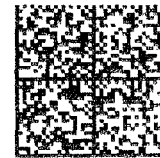

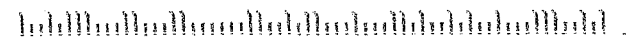
