Notice is hereby given that the Board of Zoning Adjustment (BZA) has tentatively placed the following application on its Expedited Review Calendar for a decision without a public hearing at 441 4th Street, N.W., Suite 200 South, Washington, D.C., 20001 on June 25, 2013, at 9:30 a.m. This is also the location of the Office of Zoning.

Application of Mary McGrath, pursuant to 11 DCMR § 3104.1, for a special exception to allow completion of a rear addition to an existing one-family detached dwelling under section 223, not meeting the side yard requirements (subsection 405.8) in the WH/R-1-B District at premises 4351 Klinge Street, N.W. (Square 1625, Lot 802).

If you wish for this application to be removed from the Expedited Review Calendar and scheduled for a hearing, you may either file a request for party status in opposition to the application or a request for removal and hearing of the application with the Office of Zoning no later than 14 days prior to the above-cited expedited review. A request for removal and hearing must be accompanied by a statement indicating that you or your representative intend to appear as a witness at the hearing and also include a summary of the testimony to be given at that time. The BZA Chairperson may deny a request to remove an application if the proffered testimony is irrelevant. If this application is removed, the only public notice of the hearing date will be posted in the Office of Zoning up until the date of the hearing. 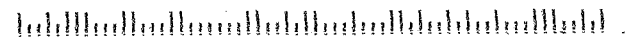
