Application of Eva R. Sanchez, pursuant to 11 DCMR § 3103.2, for a variance from the definition of yard under section 199, to allow a rear deck addition to a row dwelling occupying more than fifty (50%) percent of the rear yard area in the R-4 District at premises 620 9th Street, N.E. (Square 913, Lot 846)

Persons seeking party status shall file with the Board, not less than 14 days prior to the date set for the hearing, a Form 140 – Party Status Request form, a copy of which may be downloaded from the Office of Zoning's website at: <http://dcoz.dc.gov/services/app.shtm>. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 6A.
