This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Ronald Kaplan, pursuant to 11 DCMR § 3103.2, for a variance from lot occupancy requirements under section 403, a variance from the side yard requirements under subsection 405.9, and a variance from the nonconforming structure provisions under subsection 2001.3, to allow an addition to a one-family dwelling in the R-1-B District at premises 4916 Belt Road, N.W. (Square 1757, Lot 27).
