Application of MRC Investors LLC, pursuant to 11 DCMR § 3104 1, for a special exception under section 223, to allow a two story rear addition to an existing one-family row dwelling not meeting the lot occupancy (section 403) and rear yard (section 404) requirements in the R-4 District at premises 1177 3rd Street, N E (Square 773, Lot 276).

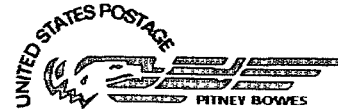
