Application of Aung Hla and Myint Myint San, pursuant to 11 DCMR § 3104.1, for a special exception to allow a two story rear addition to a semi-detached dwelling under section 223, not meeting the lot occupancy (section 403), and court (section 406), and nonconforming structure requirements in the CAP/R-4 District at premises 404 Independence Avenue, S.E. (Square 818, Lot 807).

The property involved in this application is located within the boundaries of Advisory Neighborhood Commission 6B. This application will be heard at 9:30 a.m.

The sign and the affidavit should be picked up from the Office of Zoning, Suite 200 South, 441 4th Street, N.W., Washington, D.C. 20001. Please call the Office of Zoning in advance to order your sign(s) to assure that the sign(s) will be ready when you come to pick them up. You should be aware that letters and other documents may be submitted to the Board by other individuals, organizations and government agencies both in support of and in opposition to your application. At least one week prior to the public hearing, you should review the file in your application so that you are prepared to respond to any issues that may be raised regarding your case. Further, if you are not clear about what information you must present to the Board in support of your application, please contact the Office of Zoning as soon as possible.
