5. At the conclusion of the hearing, all Zoning Signs should promptly be removed from the property.

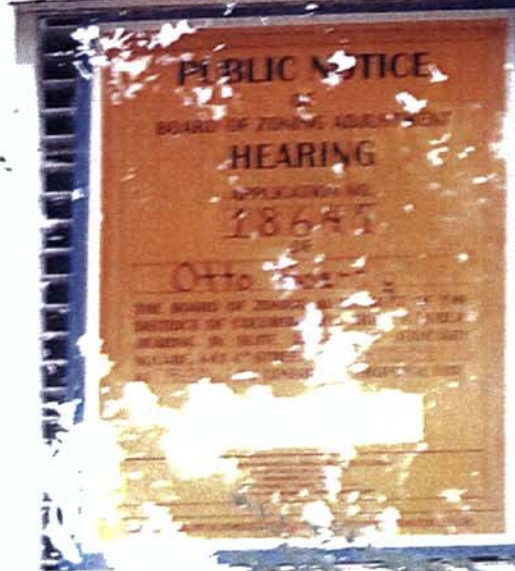
