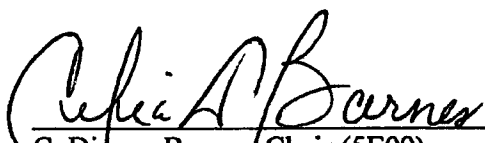

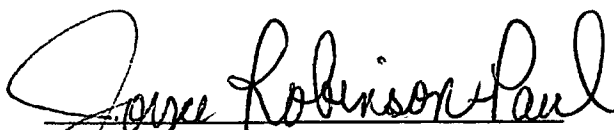
WHEREAS, Mundo Verde Public Charter School agreed that they would not take any street curb side parking on the unit block of P Street NW;

WHEREAS, the Mundo Verde Public Charter School has FILED for a parking and curb cut variance for the vacant John F. Cook Elementary School in 5E-05.

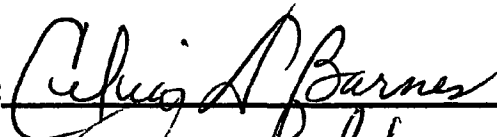
