Your application has been accepted as complete. You are hereby notified to appear before the Board of Zoning Adjustment (Board) on Tuesday, January 14, 2014, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001 for a public hearing concerning the following application:

Application of Joel and Malgorzata Spangenberg, pursuant to 11 DCMR § 3104.1, for a special exception for a two-story rear addition with cellar to an existing row dwelling and covered walkway connecting to an accessory building under section 223, not meeting the lot occupancy (section 403), rear yard (section 404) and court (section 406) requirements in the R-4 District at premises 636 A Street, S.E. (Square 869, Lot 56).

The posted notice must also be checked at least once every five days, and replaced when necessary. An affidavit concerning the original posting of the sign must be filed with the Board at least 5 days prior to the hearing. The sign and the affidavit should be picked up from the Office of Zoning, Suite 200 South, 441 4th Street, N.W., Washington, D.C. 20001. Please call the Office of Zoning in advance to order your sign(s) to assure that the sign(s) will be ready when you come to pick them up.

You should be aware that letters and other documents may be submitted to the Board by other individuals, organizations and government agencies both in support of and in opposition to your application. At least one week prior to the public hearing, you should review the file in your application so that you are prepared to respond to any issues that may be raised regarding your case.
