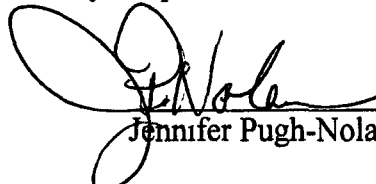

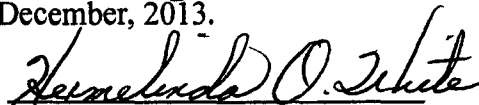

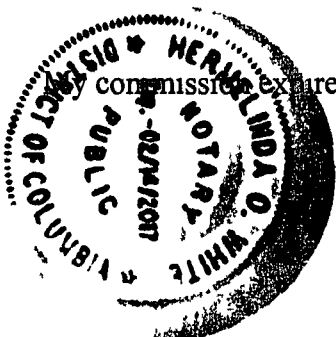
On December 20, 2013, between the hours of 10.00 a.m. and 11 00 a.m., I caused three
