In a letter dated March 25, 2014, Advisory Neighborhood Commission 2A ("ANC 2A" or "Commission") transmitted to the BZA its position regarding the above-referenced matter. ANC 2A opposes the Hyatt Place development until signage-related lighting issues, which stand to create light pollution impacts and adverse effects on residential quality of life, are resolved between the hotel and the 22 West condominium building across the street.
