Application of 1031 4th Street LLC, pursuant to 11 DCMR §§ 3104 1 and 3103 2, for a variances from the side yard requirements under section 775 5, rear yard requirements under section 774, parking requirements under section 2101 1 and loading requirements under section 2201 1, and special exception relief from the roof structure requirements under section 411 and 770 6, to allow the construction of a new mixed-use building with ground floor retail and nine stories of residential apartments in the DD/C-2-C District at premises 1031 4th Street, N W (Square 526, Lots 808, 809, 810, 811, 815, 816, 836, 837 and 838)
