Application of I.S. Enterprises Inc., pursuant to 11 DCMR § 3103.2, for variances from the lot area requirements under subsections 401.3 and 401.11, to convert an existing one-family dwelling into a new eight (8) unit apartment building in the R-4 District at premises 1328 Montello Avenue, N.E. (Square 4064, Lots 32, 33 and 34).

At the public hearing, all interested persons will be given an opportunity to express their views. However, in lieu of appearing at the hearing you may also submit written views about this case. All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded.
