Application of William Seven Street LLC, pursuant to 11 DCMR §§ 3104.1, and 3103.2, for variances from the lot occupancy requirements under section 772, the rear yard requirements under section 774, the court requirements under subsection 776.4, and the nonconforming structure provisions under subsection 2001.3, and a special exception from the roof structure requirements under subsection 411.1, to allow the addition to and renovation of an existing building for commercial and residential use in the C-2-A District at premises 1547 7th Street, N.W. (Square 445, Lot 197)

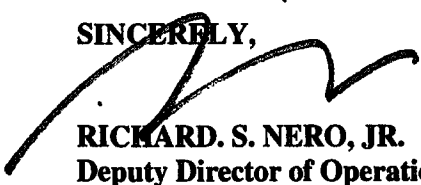
The property involved in this application is located within the boundaries of Advisory Neighborhood Commission 6E. This application will be heard at 9:30 a.m.

The posted notice must also be checked at least once every five days, and replaced when necessary. An affidavit concerning the original posting of the sign must be filed with the Board at least 5 days prior to the hearing. The sign and the affidavit should be picked up from the Office of Zoning, Suite 200 South, 441 4th Street, N W., Washington, D C. 20001. Please call the Office of Zoning in advance to order your sign(s) to assure that the sign(s) will be ready when you come to pick them up. You should be aware that letters and other documents may be submitted to the Board by other individuals, organizations and government agencies both in support of and in opposition to your application. At least one week prior to the public hearing, you should review the file in your application so that you are prepared to respond to any issues that may be raised regarding your case. Further, if you are not clear about what information you must present to the Board in support of your application, please contact the Office of Zoning as soon as possible.
