Application of Observatory Land Trust, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a variance from the lot occupancy requirements under section 403, and a special exception under section 353, to construct a new six (6) unit apartment house in the R-5-A District at premises 3915 Fulton Street, N W (Square 1806, Lot 804)

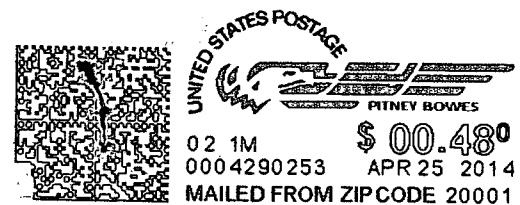

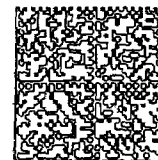

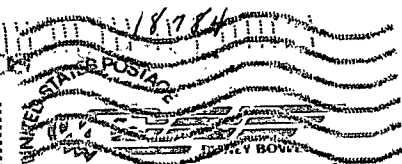
