Application of Andrea Shinbach and Matthew Sheffer, pursuant to 11 DCMR § 3104.1, for a special exception for a rear addition to an existing one-family row dwelling under section 223, not meeting the lot occupancy (section 403), court (section 406) and nonconforming structure (subsection 2001.3) requirements in the R-4 District at premises 234 9th Street, S E (Square 944, Lot 811)

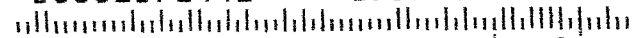

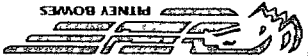
