
Application of Neighborhood Development Company, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a variance from the off-street parking requirements under subsection 2101.1, and a special exception from the roof structure requirements under subsections 411.11 and 770.6 to allow the construction of a new 20 unit multifamily residential building in the C-2-A District at premises 4308 - 4310 Georgia Avenue, N W (Square 2914, Lot 802).

Persons seeking party status shall file with the Board, not less than 14 days prior to the date set for the hearing, a Form 140 – Party Status Request form, a copy of which may be downloaded from the Office of Zoning’s website at: <http://dcoz.dc.gov/services/app.shtm>. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 4C.
