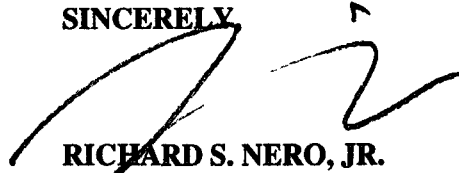
Application of Satu Haase-Webb and Michael Webb, pursuant to 11 DCMR § 3104.1, for a special exception to construct a two-story rear addition with cellar to an existing one-family row dwelling under section 223, not meeting the lot occupancy requirements (Section 403), and court requirements (Section 406.1) in the R-4 district at premises 1334 A Street, S E (Square 1036, Lot 74)

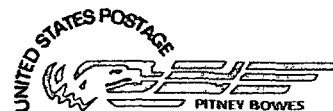
