

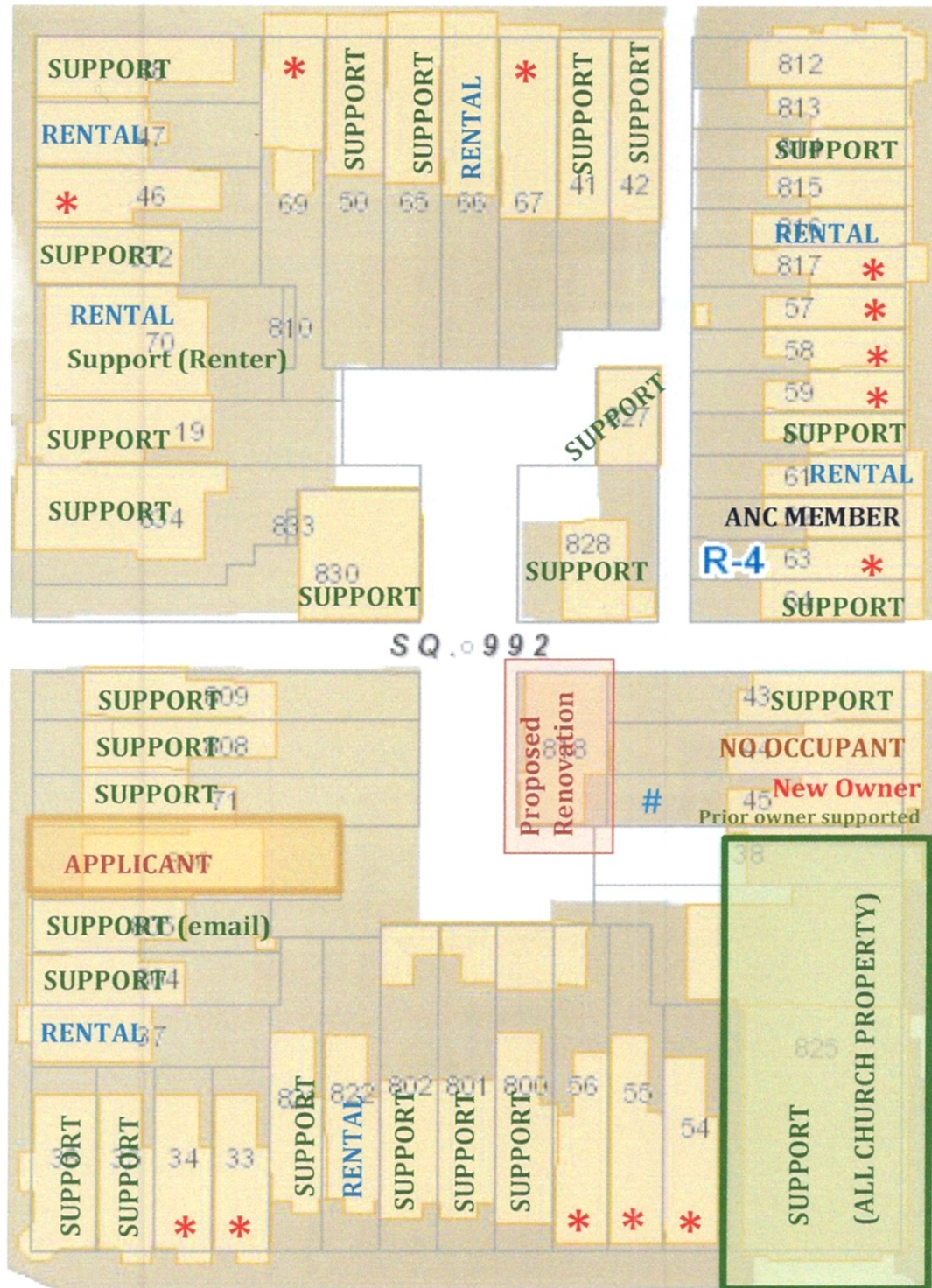

Dear Mr. Jordan and Mr. Maloney:

We, the signatories below, recently met with the Moeller family and viewed the draft architectural plans developed for their newly-purchased property (Square 992 on lot 818). This parcel is located in Walker Court, SE Washington, DC.

As neighbors and Capitol Hill residents who abut Walker Court, we support the Moeller's proposal to renovate this dilapidated one-story building into a two-story residential property.

As you may know, a similar one-story garage in Walker Court located just 15 feet from the Moeller's building was granted a waver from the city's zoning and historic authorities, permitting it to be transformed into a two-story residence late in the 1980's. At the same time, a horse stable was similarly converted into a two-story residence. A third two-story carriage house – also in the northern end of Walker Court – now houses both a residence and photography studio.

These three existing residences add to the character of the block. An additional residential building in Walker Court would enhance the look and feel of the court area, add vitality to the otherwise quiet southern side of Walker Court and provide an added layer of security to the Sothern section of the alley. Much of this section of Walker court is currently out of view from most homes on the block. Break-ins of both homes and cars have occurred as a result.

As shown in their draft plans, the Moeller's intend to preserve the lower floor of the building as an extension of their current home's living space. The upper level and associated roof deck is planned as a rental property.

We are pleased to support this project as an improvement to our neighborhood.
