Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N W , Suite 220 South, Washington, D C., 20001 on Tuesday, October 28, 2014, on the following application.

Application of Government of the District of Columbia, pursuant to 11 DCMR § 3104.1, for a special exception under subsection 2713.2(a), to allow the construction of a new 200 foot tall radio tower/monopole and associated equipment in the R-5-A District at premises 4650 Benning Road, S E (Fletcher Johnson School Site) (Square 5344, Lot 802)
