Application of Government of the District of Columbia, pursuant to 11 DCMR § 3104 1, for a special exception under subsection 2713 2(a), to allow the construction of a new 200 foot tall radio tower/monopole and associated equipment in the R-5-A District at premises 4650 Benning Road, S E (Fletcher Johnson School Site) (Square 5344, Lot 802)
