Application of Government of the District of Columbia, pursuant to 11 DCMR § 3104.1, for a special exception under subsection 2713.2(a), to allow the construction of a new 200 foot tall radio tower/monopole and associated equipment in the R-5-A District at premises 4650 Benning Road, S E (Fletcher Johnson School Site) (Square 5344, Lot 802).

This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 7E. 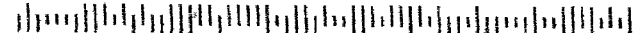

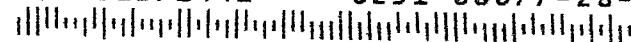

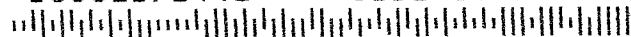
