Application of Latham Owner SPE LLC, pursuant to 11 DCMR §§ 3104 1, and 3103 2, for variance relief from the rear yard (section 933), parking (subsection 2101 1), and loading (subsection 2201 1) requirements and special exception approval to locate 20 parking spaces in an off-site parking facility (subsection 2116 5) to permit the conversion of an existing hotel with accessory retail into a mixed-use residential and retail building in the C-2-A and W-1 Districts at premises 3000 M Street, N W (Square 1197, Lot 70)
