

Choharis, pursuant to 11 DCMR § 3103.2, for a variance from minimum lot dimensions under section 401, a variance from the lot occupancy requirements under section 403, a variance from rear yard requirement under section 404, a variance from the minimum dimension for open courts under section 406, and a variance from the nonconforming structure under subsection 2001.3, to allow for a rear deck addition serving a flat in the R-4 District at premises 2771 Woodley Place, N W (Square 2206, Lot 87).

This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 3C. 


