Re: BZA Case 18850

At a properly noticed community meeting on October 8, 2014 and with a quorum present, the 4C Commissioners voted to support the BZA application (BZA Case 18850) for a permanent exception and variance by The Parkmont School.

Parkmont, is one of the three (3) private schools located within close proximity of each other in this R1 residential zoned community. The community has had an excellent working relationship with Parkmont over the years that Parkmont has operated in the community under its conditional BZA authorizations. The community is supportive of fair treatment of each private school and since the BZA approved the Jewish Primary Day School's request for variance without requiring periodic renewals, the community expects that Parkmont will be approved to no longer seek periodic renewals.

While we are confident that the current leadership of Parkmont has noted the community's concerns and will adhere to them to the greatest extent possible, we are concerned, as a community, that there is (1) no adequate mechanism to monitor compliance with traffic and transportation plans and other operational requirements after permanent authorizations are granted by the BZA to private schools, and (2) a need to clearly inform future operations at these schools when there is a change in staffing or ownership of the commitments in their special exception or other zoning applications. Accordingly, we believe the community's concerns and Parkmont's commitments discussed below should be clearly captured and reflected in the BZA Order.

ANC 4C Community Concerns and Parkmont Commitments

1. ANC 4C Community Concern: Student Access to Lunch Onsite

The community highlighted past Parkmont student lunch policy where students purchased lunch at 14th street carry-outs and consumed them on the way back to the school. We have been informed by Parkmont's Head of School, Ron McClain, that this has been addressed years ago and students eat lunch on campus. Students only leave campus during the daytime to travel to internships.

2. ANC 4C Community Concern: Monitoring Variance for Staff/Student Parking

Parkmont indicates that under the variance, staff will park at the Carter-Barron. Parkmont states that it orients new staff members and new student drivers about the school's parking policy and regularly reminds all staff about that policy. It also monitors staff and student parking, visits Carter Barron and pays attention to members exit patterns from school. ANC 4C will listen to community feedback and contact school leadership should the community observe students and staff parking on the neighboring streets.

3. **ANC 4C Community Concern: Use of the Facility for School Related Activities Only**

Parkmont states in its detailed statement of existing and intended use of the structure that it will be used only for school-related activities as follows:

- Operation of the school shall be limited to the Parkmont School.
- There shall be no non-school-related activities on the subject premises.

Parkmont leadership has affirmed these requirements, and it is, in fact, only used for school-related activities at all times.

4. **ANC 4C Community Concern: Maintaining Landscaping & Not Enlarging Paved Area**

Parkmont states in its detailed statement of existing and intended use of the structure that:

- Landscaping on the premises shall be maintained as approved in BZA Order No. 13985 and in healthy growing condition
- There shall be no enlargement of the existing paved area on the site.

Once again, Parkmont leadership has informed 4C that twice in their 24 year history on the site they have repaired the existing pavement on the property without expanding it.

Parkmont also conducts regular landscaping around its property.

5. **ANC 4C Community Concern: Notification to the community of major school-related activities**

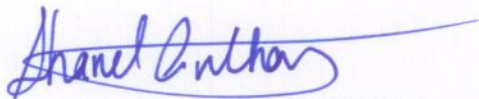
In the event Parkmont holds large school-related activities, leadership has stated that they will work to notify the community by way of emailing community representatives. School leadership has informed ANC 4C that they do not regularly have evening events, except for Board meetings (five per year) and four school events.

6. **ANC 4C Community Concern: Monitoring of trash collection services**

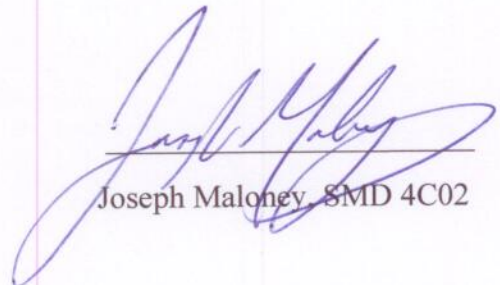
Parkmont has noted to ANC 4C that their trash collections services take place during the afternoon, with their waste management provider being on-time approximately 60% of the time. Leadership at the school will continue to encourage their vendor to commit to appropriate times in accordance with District of Columbia regulations.

In light of Parkmont's response to the ANC4C Community Concerns 1-6 above, ANC4C supports Parkmont's application for a special exception and variance subject to the BZA addressing enforcement concerns and that Community Concerns 1-6 above are clearly reflected in the BZA Order.
